

**USER GUIDE FOR
SUBMISSION OF REPEAT TITLES WITH
IDENTICAL CONTENT
FOR PUBLIC EXHIBITION
(‘FRT’)**

Submission of Repeat Titles with Identical Content under Standard Service

Definition

- 'FRT' submissions are for titles where the content is identical to a version previously classified by IMDA, and with the decision 'Passed Clean with Condition' or with dialect content meant for public exhibition purposes.
- The 'FRT' submission must be approved by the IMDA before exhibiting.

Fees and Service Standards

- The fee is \$50 per title.
- 'FRT' submissions will be processed within 10 working days.
- Applicants must ensure that their applications and submitted materials meet the requirements of the Submission Guidelines.
- The guidelines can be found on the IMDA website and the IMDA Online e-Services webpage.




At the Online Services page, under the **Film Classification for Public Exhibition**, select **Submission of Repeat Titles with Identical Content ('FRT')**
