## **Submission of Titles for Re-classification under Standard Service**

### **Definition**

- 'RA' refers to re-classification of titles that have been classified previously by the IMDA and meant for commercial distribution.

### **Fees and Service Standards**


- The classification fee is \$10 per half an hour or part thereof.
- 'RA' submissions will be classified within 40 working days.
- Applicants must ensure that their applications and submitted materials meet the requirements of the Submission Guidelines.
- The guidelines can be found on the IMDA website and the IMDA Online e-Services webpage.
