New Title Submission under Express Service

Definition

- 'XFA' submissions are for classification of a new title meant for public exhibition, with a shorter turnaround time and at a surcharge.

Fees and Service Standards


- The classification fee is \$123 per half an hour or part thereof.
- 'XFA' submissions will be classified within 5 working days.
- Applicants must ensure that their applications and submitted materials meet the Submission Guidelines.
