

**USER GUIDE FOR
SUBMISSION OF NEW TITLES
FOR DISTRIBUTION
(‘A’)**

New Title Submission under Standard Service

Definition

- 'A' submissions are for classification of the first or master copy of a film meant for commercial distribution.
- The 'A' submission must first be approved by the IMDA. The distributor can then use the approved 'A' submission for certification of subsequent duplicate copies for distribution.

Fees and Service Standards

- The classification fee is \$10 per half an hour or part thereof and the classification label is \$0.80 per copy.
- 'A' submissions will be classified within 40 working days.
- Applicants must ensure that their applications and submitted materials meet the requirements of the Submission Guidelines.
- The guidelines can be found on the IMDA website and the IMDA Online e-Services webpage.

Film Classification for Distribution IMDA Submissions Guidelines for Films


Submission Of New Titles (A)
Submission of the first or master copy of a film that the applicant will be using for certification of subsequent duplicate copies

Submission Of Repeat Titles With Identical Content (RT)
Submission for titles where the main feature and any included extra features are identical to a version that has been previously classified by IMDA

Step 1:

At the Online Services page, under the **Film Classification for Distribution**, select Submission of New Titles (A)
