## **Submission of Films with Party Political Content under Standard Service**

### **Definition**

- 'FP' submissions are for classification of films made by or on behalf of a political party or containing any party political content meant for public exhibition.

### **Fees and Service Standards**


- The classification fee is \$82 per half an hour or part thereof.
- 'FP' submissions will be classified within 30 working days.
- Applicants must ensure that their applications and submitted materials meet the requirements of the Submission Guidelines.



At the Online Services page, under the **Film Classification for Public Exhibition**, select **Submission of Films with Party Political Content ('FP')**




