(‘FR’)**

Submission of Titles for Re-classification under Standard Service

Definition

- 'FR' refers to re-classification of titles that have been classified previously by the IMDA and meant for commercial public exhibition.
- The 'FR' submission must first be approved by the IMDA before exhibiting.
- An exhibitor will be using the approved 'FR' submission for certification of subsequent duplicate copies for public exhibition.

Fees and Service Standards

- The classification fee is \$82 per half an hour or part thereof and the classification label is \$0.80 per copy.
- 'FR' submissions will be classified within 30 working days.
- Applicants must ensure that their applications and submitted materials meet the requirements of the Submission Guidelines.
- The guidelines can be found on the IMDA website and the IMDA Online e-Services webpage.






