New Title Submission for Non-Profit Use

Definition

- 'NA' submissions are for classification of the first or master copy of a film meant for non-profit distribution.
- The 'NA' submission must first be approved by the IMDA. The distributor can then use the approved 'NA' submission for certification of subsequent duplicate copies for distribution.

Fees and Service Standards

- The classification fee is \$2.50 per half an hour or part thereof and the classification label is \$0.80 per copy.
- 'NA' submissions will be classified within 40 working days.
- Applicants must ensure that their applications and submitted materials meet the requirements of the Submission Guidelines.
- The guidelines can be found on the IMDA website and the IMDA Online e-Services webpage.




