**For Non-Profit Use
(‘NRA’)**

Submission of Titles for Re-classification for Non-Profit Use

Definition

- 'NRA' refers to re-classification of titles that have been classified previously by the IMDA, and meant for non-profit distribution.
- The 'NRA' submission must first be approved by the IMDA before distributing.
- A distributor will be using the approved 'NRA' submission for certification of subsequent duplicate copies for distribution.

Fees and Service Standards

- The classification fee is \$2.50 per half an hour or part thereof and the classification label is \$0.80 per copy.
- 'NRA' submissions will be classified within 40 working days.
- Applicants must ensure that their applications and submitted materials meet the requirements of the Submission Guidelines.
- The guidelines can be found on the IMDA website and the IMDA Online e-Services webpage.




