**For Non-Profit Use
(‘NSA’)**

Submission of Titles to Obtain An Indicative Rating for Non-Profit Use

Definition

- 'NSA' submissions are for distributors or exhibitors to obtain an indicative rating for unfinished product prior to their non-profit distribution or public exhibition, such as Screeners.
- The indicative rating issued is not for the purpose of distribution or public exhibition.
- The final version of the film must be submitted for classification if it is meant for distribution or public exhibition.

Fees and Service Standards


- The classification fee is \$2.50 per half an hour or part thereof.
- 'NSA' submissions will be classified within 30 working days.
- Applicants must ensure that their applications and submitted materials meet the requirements of the Submission Guidelines.


Step 2:
