## **Submission of Repeat Titles with Identical Content under Standard Service**

### **Definition**

- 'RT' submissions are for titles meant for distribution where the main feature and any included extra features are identical to a version that has been previously classified by IMDA.
- The 'RT' submission must first be approved by the IMDA. The distributor can then use the approved 'RT' submission for certification of subsequent duplicate copies for distribution.

### **Fees and Service Standards**

- The fee is \$10 per title and the classification label is \$0.80 per copy.
- 'RT' submissions will be processed within 5 working days.
- Applicants must ensure that their applications and submitted materials meet the requirements of the Submission Guidelines.
- The guidelines can be found on the IMDA website and the IMDA Online e-Services webpage.
